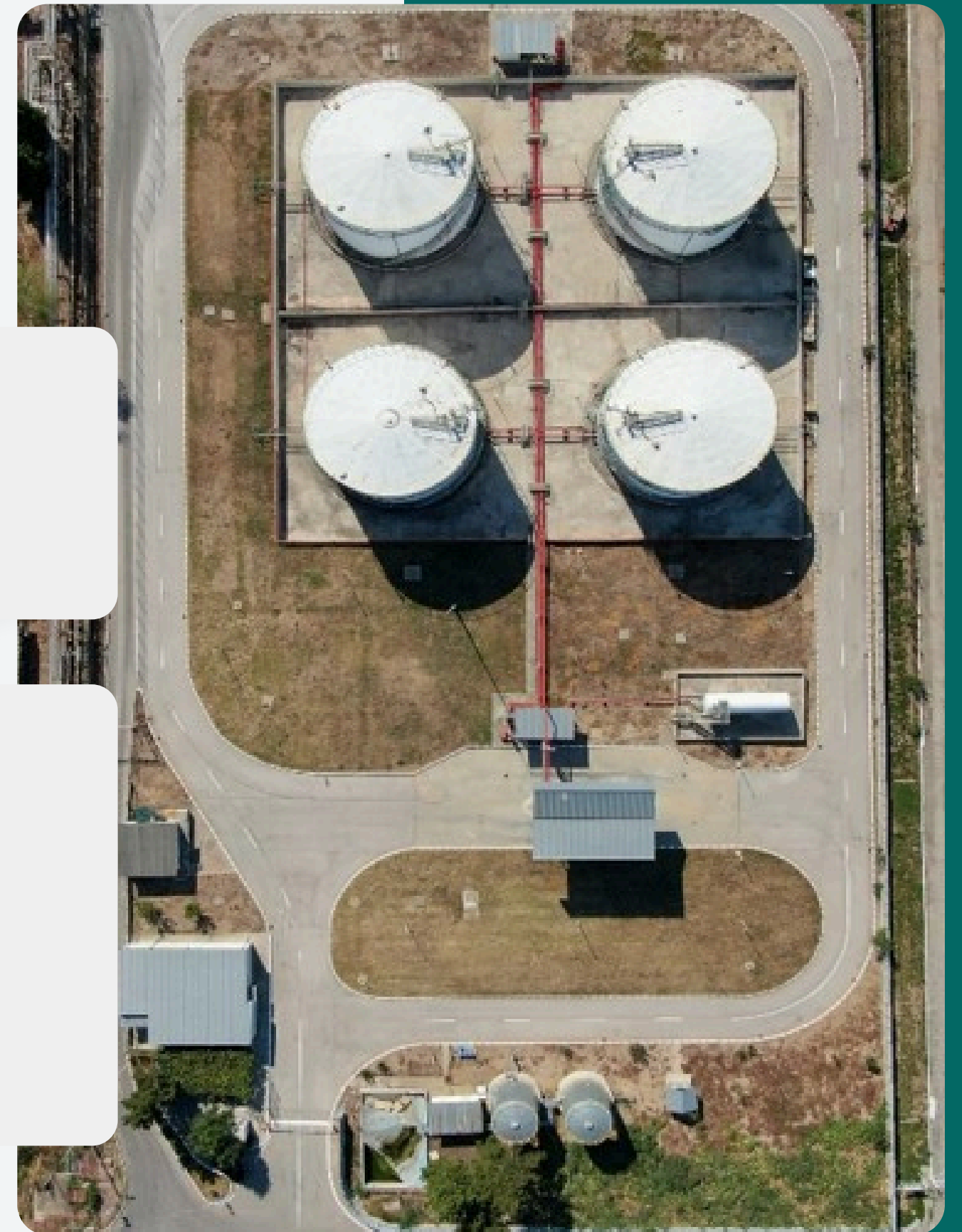
ABOUT US

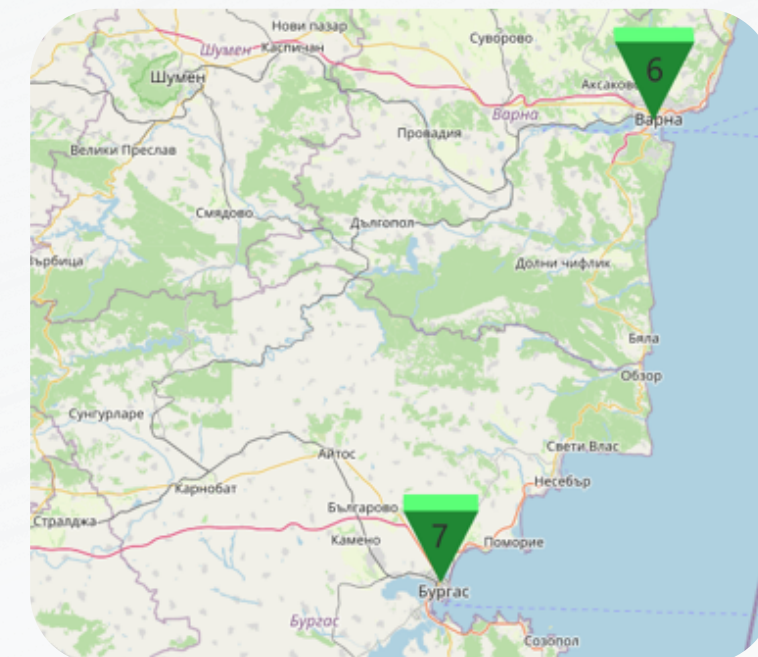
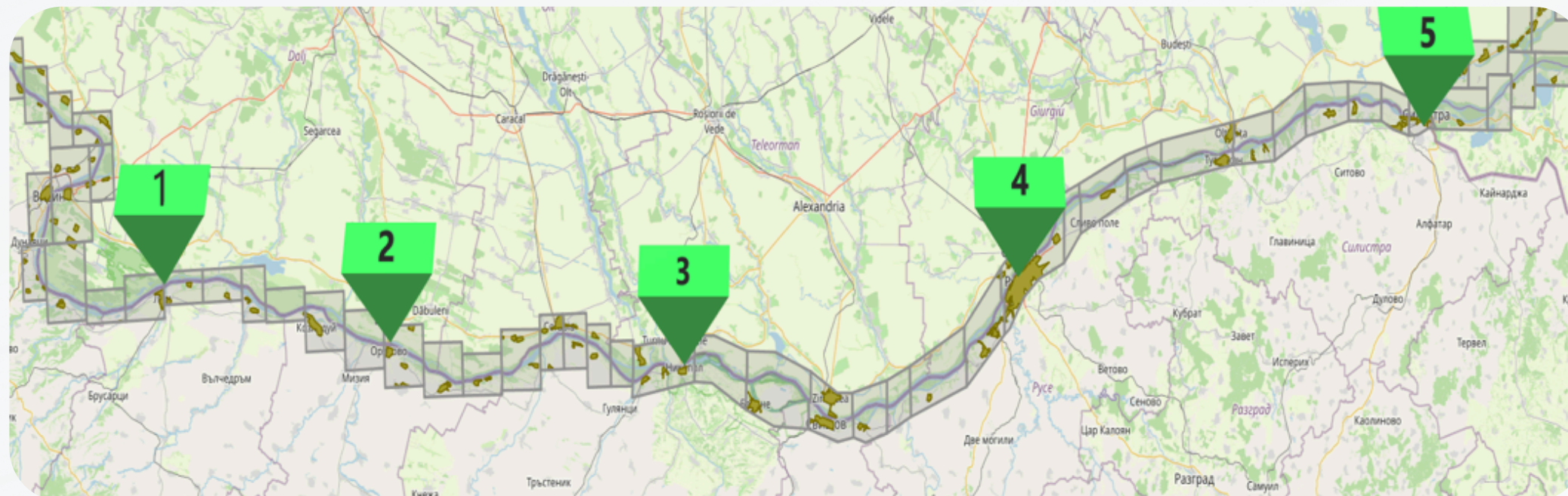

SAFETY PROCEDURES AND STANDARDS IN BUNKERING

For safety reasons, bunkering operations are conducted during daylight hours. We maintain continuous radio communication between the truck driver, who controls the fuel flow, and the person receiving the fuel on the vessel. This ensures a safe and efficient bunkering process while adhering to industry standards.

The role of the agent in managing motor vessels

- The role of the agent is of utmost importance for ensuring swift and efficient processes when entering and exiting the territory of the Republic of Bulgaria.

Client support and coordination with various authorities

- The agent will ensure seamless communication between the shipowner and the relevant authorities, including Customs Agency, Border Police, Maritime Administration, and River Control.
- The agent will also assist the ship's crew in every possible way when needed. In summary, the agent is responsible for ensuring the smooth entry, stay, and departure of the vessel and its crew from the territory of the Republic of Bulgaria.

Documentation and permitting process

- The agent will handle all responsibilities related to submitting the required documentation to the relevant authorities. For this purpose, communication between the agent and the ship's captain is established as early as possible, prior to the vessel's arrival in Bulgaria.
